JAGs Career and College Readiness program served 627 middle school and high school youth and 335 recent graduates, providing an average of 120 hours of service per participant. Programming is delivered as a regularly scheduled, for credit elective class, which creates a reliable support system for JAG students. With a focus on team building and student led activity based learning, the class provides an alternative to the typical classroom experience, while still delivering JAGs competency based work readiness curriculum. In the classroom, JAG students receive instruction on core work readiness competencies designed to ensure successful transition to employment and or post secondary education upon graduation from high school. JAGs core curriculum includes Career development, Job Attainment, Job survival, Leadership and Self development, and Personal skills. Outside of the classroom, all JAG students are members of a student led organization that functions within the classroom, serving as a learning lab for the JAG curriculum. This student led organization often becomes the heart of the program, allowing the students to build relationships with each other and members of their school and community as they work together to plan career exploration and social and community service events. For the class of 2020, 98 percent of traditional JAG participants graduated, and of those, 95 percent were positively engaged in employment and/or post secondary education.

The JAG Works Community based program takes the content that JAG is known for and makes it available through local community center facilities. JAG Works engages youth in a multitude of ways including project based learning activities, weekly educational workshops, leadership development, community service, professional association community activities, career and educational focused field trips, guest speakers, student conferences, and Leadership Camp. JAG works served 30 high school students and 13 recent graduates. For the class of 2020, more than 100 percent graduated were engaged in employment or post secondary education one year after graduation.
