With a focus on team building and student led activity based learning, the class provides an alternative to the typical classroom experience, while still delivering JAG's competency based work readiness curriculum. In the classroom, JAG students receive instruction on core work readiness competencies designed to ensure successful transition to employment and or post secondary education upon graduation from high school. JAG's core curriculum includes Career development, Job Attainment, Job survival,
